- PLAYERS PASS (\$1,800+tax = \$1,926)**
- ADDITIONAL FAMILY MEMBER – 13 YEARS OR OLDER (\$1,000+tax = \$1,070/each)**
- ADDITIONAL FAMILY MEMBER – 12 YEARS OR YOUNGER (\$500+tax = \$535/each)**
- CREDIT CARD FEE (\$100)**

The annual fee of _____ is **DUE IN FULL** upon execution of this Agreement enables Players Pass Holder to use of all Club facilities and privileges as described in the Agreement from opening day of season 2023 to closing day of season 2023.

Privileges/ Benefits: Privileges as defined in this plan are available to the primary Players Pass Holder (and additional family member if applicable) only, who is referred to herein as the "Players Pass Holder". Players Pass Holder includes \$20 golf rounds, cart fees, practice balls, unlimited use of the practice facility, 14 day advance tee times, 10% discount on *select* merchandise, and reciprocal program. Players Pass Holders are also allowed to have accompanied golf guests. Players Pass Holders shall receive preferential rates for accompanied guests.

Tee Time/Reservation Privileges: Each Players Pass Holder will be entitled to reserve a tee time no more than 14 days in advance. Tee Time Reservations must be made online at tcofiowa.com. If you do not wish to book your tee time online, you may play on a space available basis but will not be guaranteed a specific tee time.

Cancellation Policy: Players Pass Holder will be held responsible for any abandoned tee times not canceled prior to the 24-hour cancellation period. There will be a \$20 No Show/Short Show Fee per player. No Show/Short Show Fees are nonrefundable. Players Pass Holder will be required to keep updated credit card on file.

Management of Club Facilities: Tournament Club of Iowa reserves the right to restrict or to otherwise reserve the club facilities for such purposes as the company deems appropriate including, without limitation, maintenance, tournament play, promotional activities, and special events.

Initial

General Club Rules and Policies: Players Pass Holders will be required to comply with any club rules and policies of Tournament Club of Iowa set forth herein or otherwise implied hereafter. Any Players Pass Holder who violates this agreement or otherwise engages in conduct detrimental to Tournament Club of Iowa is subject to revocation of Players Pass Holder and all associated privileges **without refund**. All Players Pass Holders are responsible for their guests' conduct and behavior.

Dress Code: Proper golf attire is preferred.

Check-in: All Players Pass Holders must check into the golf shop prior to playing, there are no exceptions.

GENERAL TERMS AND CONDITIONS

PLAYERS PASS HOLDERSHIP QUALIFICATIONS

Any individual of responsible character and proven financial responsibility without regard to race, sex, ethnic background or religion is eligible for a Players Pass Holder at Tournament Club of Iowa. Players Pass Holder in the club includes the Players Pass Holder's right to utilize the club facilities within the framework of these terms and conditions and in accordance with the club rules and regulations, which may change from time to time at the discretion of Tournament Club of Iowa. It does not infer any authority in the management of the club or any interest in the property or assets of the club.

PLAYER PASS HOLDERSHIP PROVISIONS

The Player Pass Holder information application must be completed and signed by the Player Pass Holder or prospective Player Pass Holder before the Player Pass Holder process can begin. The name that appears on the signed Player Pass Holder application will be considered the Player Pass Holder. **Player Passes are non-transferable and not assignable by the Player Pass Holder.**

PLAYER PASS HOLDERSHIP SALES ALLOCATION / WAITING LIST / ROSTER NUMBER

Player Pass Holders at Tournament Club of Iowa will be limited to the first 150 applications processed and applications will be considered approved when signed by the General Manager. The club, at its sole discretion, has the right to change the number of available Players Pass Holders.

RULES AND REGULATIONS

All Players Pass Holders agree to abide by the club rules and regulations while in the club facility. These rules and regulations may change from time to time in the discretion of Tournament Club of Iowa. Failure to abide by the club rules and regulations may result in termination of Player Pass Holder.

DAMAGES

Players Pass Holders accept responsibility for all property damages (including golf carts) except due to ordinary wear and usage caused by themselves or their guests. The club shall not be liable to Players Pass Holders and their guests for property damaged, lost, or stolen in or about the club and the Players Pass Holder hereby releases Tournament Club of Iowa from any such loss.

RIGHTS TO CANCELLATION

Players Pass Holders may only this obligation for any of the following reasons:

1. In the event of a Players Pass Holder's death, the Players Pass Holder's estate may cancel the contract. The canceling Players Pass Holder may be entitled to a refund of any prepaid annual dues or fees, which will be pro-rated from the date the written notification is received by Tournament Club of Iowa.
2. If the Players Pass Holder becomes significantly physically or mentally disabled for a period in excess of three months with reasonable evidence of illness, including a notification from their doctor.
Request for discontinuance of Players Pass Holder must be in writing. All check refund consideration will be taken on a case-by-case basis and will be pro-rated from the time of receipt of written notification.

REFUND/POLICY CHANGES

The club reserves the right to change fees, services, and operational procedures without prior notice to the Players Pass Holder.

SUSPENSION AND TERMINATION

The club may terminate a Players Pass Holder by notification in writing, at the last address shown on club records for that Players Pass Holder. A terminated Players Pass Holder will remain liable for all indebtedness incurred. At the sole discretion of the club management, the Players Pass Holder of any Players Pass Holder who is in arrears in his or her account to the club may be suspended or terminated.

SEVERABILITY

In the event any part or parts of this agreement are determined invalid or unenforceable, such part or parts shall be severed and their remainder shall be in effect.

GENERAL

This agreement may not be assigned or otherwise transferred, in whole or in part, by the Players Pass Holder. This agreement shall be governed by the laws of Iowa, exclusive of its choice of law provisions. In the event that Tournament Club of Iowa commences any action to recover amounts due from the Players Pass Holder, it shall be entitled to recover its attorneys’ fees and costs. No provision of this agreement may be waived, unless such waiver is in writing. No waiver in any one instance shall be effective in any other instance. The fact that one party or the other party drafted this agreement shall not be considered in the interpretation of this agreement. The obligations of an Players Pass Holder to Tournament Club of Iowa shall survive any termination or cancellation of this agreement. Any liability of Tournament Club of Iowa to the Players Pass Holder shall be limited to return of the initial annual fee.

AGREEMENT

Players Pass Holder is subject to approval by Tournament Club of Iowa and shall be effective only when Tournament Club of Iowa approves this agreement. The undersigned states that he/she has read and understands the Terms and Conditions of this agreement; agrees to be bound by such Terms and Conditions and acknowledges that he/she has received a copy of this Agreement. Any account balances must be paid in full prior to termination.

Acceptance and approval by Tournament Club of Iowa constitutes a contract between the parties granting the Applicant all rights and privileges afforded to the applicable Players Pass Holder under the current Terms and Conditions. Rules and Regulations, Terms and Conditions and the General Terms and Conditions may be amended from time to time at Tournament Club of Iowa discretion. Tournament Club of Iowa reserves the right to cancel any Players Pass Holder in part or in full with or without cause.

The provisions of the Terms and Conditions and the General Terms and Conditions are hereby incorporated in this Agreement. Each party has read this Agreement and understands the contents thereof. Signature below indicates that there are no questions about the terms of this Agreement and the obligations of the parties and the Players Pass Holder intends to be bound hereby.
