The annual fee of \_\_\_\_\_ **DUE IN FULL** upon execution of this Agreement enables Corporate Pass Holder to use of all Club facilities and privileges as described in the Agreement from opening day of season 2025 to closing day of season 2025.

**Privileges/ Benefits:** Privileges as defined in this plan are available to the primary Corporate Pass Holder (and guests) only, who is referred to herein as the "Corporate Pass Holder". Corporate Pass Holder includes green fee, cart fee, and practice balls, use of the practice facility, valid for a tee time up to a foursome Monday-Thursday, and a tee time up to a foursome Friday-Sunday. 14 day advance tee times, 10% discount on *select* merchandise, and GPS Advertising. Corporate Pass Holders are also allowed to have accompanied golf guests. Corporate Pass Holders shall receive preferential rates for accompanied guests.

**Tee Time/Reservation Privileges:** Each Corporate Pass Holder will be entitled to reserve a tee time no more than 14 days in advance. Tee Time Reservations must be made online at [tcofiowa.com](http://tcofiowa.com). If you do not wish to book your tee time online, you may play on a space available basis but will not be guaranteed a specific tee time.

**Cancellation Policy:** Corporate Pass Holder will be held responsible for any abandoned tee times not canceled prior to the 24-hour cancellation period. There will be a \$20 No Show/Short Show Fee per player. No Show/Short Show Fees are nonrefundable. Corporate Pass Holder will be required to keep updated credit card on file.

**Management of Club Facilities:** Tournament Club of Iowa reserves the right to restrict or to otherwise reserve the club facilities for such purposes as the company deems appropriate including, without limitation, maintenance, tournament play, promotional activities and special events.

**General Club Rules and Policies:** Corporate Pass Holders will be required to comply with any club rules and policies of Tournament Club of Iowa set forth herein or otherwise implied hereafter. Any Corporate Pass Holder who violates this agreement or otherwise engages in conduct detrimental to Tournament Club of Iowa is subject to revocation of Annual Pass Holder and all associated privileges **without refund**. All Corporate Pass Holders are responsible for their guests' conduct and behavior.

## **GENERAL TERMS AND CONDITIONS**

### **CORPORATE PASS HOLDERSHIP QUALIFICATIONS**

Any individual of responsible character and proven financial responsibility without regard to race, sex, ethnic background or religion is eligible for an Corporate Pass Holder at Tournament Club of Iowa. Corporate Pass Holder in the club includes the Corporate Pass Holder's right to utilize the club facilities within the framework of these terms and conditions and in accordance with the club rules and regulations, which may change from time to time at the discretion of Tournament Club of Iowa. It does not infer any authority in the management of the club or any interest in the property or assets of the club.

### **CORPORATE PASS HOLDERSHIP PROVISIONS**

The Corporate Pass Holder information application must be completed and signed by the Corporate Pass Holder or prospective Corporate Pass Holder before the Corporate Pass Holder process can begin. The name that appears on the signed Corporate Pass Holder application will be considered the Corporate Pass Holder. **Corporate Passes are non-transferable and not assignable by the Corporate Pass Holder.**

### **ANNUAL PASS HOLDERSHIP SALES ALLOCATION / WAITING LIST / ROSTER NUMBER**

Annual Pass Holders at Tournament Club of Iowa will be limited to the first 150 applications processed and applications will be considered approved when signed by the General Manager. The club, at its sole discretion, has the right to change the number of available Corporate Pass Holders.

### **RULES AND REGULATIONS**

All Corporate Pass Holders agree to abide by the club rules and regulations while in the club facility. These rules and regulations may change from time to time in the discretion of Tournament Club of Iowa. Failure to abide by the club rules and regulations may result in termination of Corporate Pass Holder.

### **DAMAGES**

Corporate Pass Holders accept responsibility for all property damages (including golf carts) except due to ordinary wear and usage caused by themselves or their guests. The club shall not be liable to Corporate Pass Holders and their guests for property damaged, lost, or stolen in or about the club and the Corporate Pass Holder hereby releases Tournament Club of Iowa from any such loss.

### **RIGHTS TO CANCELLATION**

Corporate Pass Holders may only this obligation for any of the following reasons:

1. In the event of a Corporate Pass Holder's death, the Corporate Pass Holder's estate may cancel the contract. The canceling Corporate Pass Holder may be entitled to a refund of any prepaid annual dues or fees, which will be pro-rated from the date the written notification is received by Tournament Club of Iowa.
2. If the Corporate Pass Holder becomes significantly physically or mentally disabled for a period in excess of three months with reasonable evidence of illness, including a notification from their doctor. Request for discontinuance of Corporate Pass Holder must be in writing. All check refund consideration will be taken on a case-by-case basis and will be pro-rated from the time of receipt of written notification.

### **REFUND/POLICY CHANGES**

The club reserves the right to change fees, services, and operational procedures without prior notice to the Corporate Pass Holder.

### **SUSPENSION AND TERMINATION**

The club may terminate a Corporate Pass Holder by notification in writing, at the last address shown on club records for that Corporate Pass Holder. A terminated Corporate Pass Holder will remain liable for all indebtedness incurred. At the sole discretion of the club management, the Corporate Pass Holder of any Annual Pass Holder who is in arrears in his or her account to the club may be suspended or terminated.

**SEVERABILITY**

In the event any part or parts of this agreement are determined invalid or unenforceable, such part or parts shall be severed and their remainder shall be in effect.

**GENERAL**

This agreement may not be assigned or otherwise transferred, in whole or in part, by the Corporate Pass Holder. This agreement shall be governed by the laws of Iowa, exclusive of its choice of law provisions. In the event that Tournament Club of Iowa commences any action to recover amounts due from the Corporate Pass Holder, it shall be entitled to recover its attorneys’ fees and costs. No provision of this agreement may be waived, unless such waiver is in writing. No waiver in any one instance shall be effective in any other instance. The fact that one party or the other party drafted this agreement shall not be considered in the interpretation of this agreement. The obligations of a Corporate Pass Holder to Tournament Club of Iowa shall survive any termination or cancellation of this agreement. Any liability of Tournament Club of Iowa to the Corporate Pass Holder shall be limited to return of the initial annual fee.

**AGREEMENT**

Corporate Pass Holder is subject to approval by Tournament Club of Iowa and shall be effective only when Tournament Club of Iowa approves this agreement. The undersigned states that he/she has read and understands the Terms and Conditions of this agreement; agrees to be bound by such Terms and Conditions and acknowledges that he/she has received a copy of this Agreement. Any account balances must be paid in full prior to termination.

Acceptance and approval by Tournament Club of Iowa constitutes a contract between the parties granting the Applicant all rights and privileges afforded to the applicable Corporate Pass Holder under the current Terms and Conditions. Rules and Regulations, Terms and Conditions and the General Terms and Conditions may be amended from time to time at Tournament Club of Iowa discretion. Tournament Club of Iowa reserves the right to cancel any Corporate Pass Holder in part or in full with or without cause.

The provisions of the Terms and Conditions and the General Terms and Conditions are hereby incorporated in this Agreement. Each party has read this Agreement and understands the contents thereof. Signature below indicates that there are no questions about the terms of this Agreement and the obligations of the parties and the Corporate Pass Holder intends to be bound hereby.
